

MEDFORD-PARK FALLS RANGER DISTRICT


Features

- 27 campsites
- Drinking water
- Reservable campsites
- Campground host (summer)
- Boat landing & reservable shelter
- Located on the 416 acre Mondeaux Flowage
- Ice Age National Scenic Trail passes near the campground
- Mondeaux Dam Lodge with food, boat rentals, firewood and showers nearby
- Good fishing for musky, northern pike, large mouth bass, crappie, perch, and panfish



Accessible features include:

Fire rings, tables, vault toilet facilities and fishing pier at nearby Lakeview day use site.



Location

Spearhead Point Campground is located on Forest Road 106, along the west side of the Mondeaux Flowage.

- From County Highway D, take FR 104 south for 1.1 miles to the intersection of FR 106. Continue on FR 106 for 1.6 miles to the campground entrance.

Campsite Capacity

Individual Campsite capacity may not exceed 4 vehicles and 8 people.

- Vehicle capacity limit includes both wheeled camping unit and vehicles

Operation of all ATVs & UTVs are prohibited in campground

Boat landing and parking for paying campers only

Description

Spearhead Point Campground is located in a mature hardwood forest along the western shore of the Mondeaux Flowage. Located near the campground are a variety of commercial services including canoe & boat rentals, showers, and some food and firewood sales at the Mondeaux Dam Lodge. There is no long term or day use parking for people entering the Ice Age National Scenic Trail within the campground. RV Dump Station is provided by Mondeaux Dam Lodge (Dumping Fees Apply).



Campground Fees

Campsite fee is \$12, or \$6 with use of Interagency Senior or Access Pass and lakeside campsite fee is \$14, or \$7. Interagency Pass discounts apply only to the fee for the campsite physically occupied by the pass holder, not to any additional fee or campsite(s) occupied by members of the pass holder's party.



Firewood Closure Order

Our firewood closure order prohibits the possession, storage, or transport of any firewood that originates from more than 25 miles from your campsite. Firewood certified by the Wisconsin Department of Agriculture, Transportation and Consumer Protection can originate from more than 25 miles from National Forest destination. Both certified firewood and Kiln-dried, untreated/unpainted/unstained/construction/dimensional lumber that is free of any metal or foreign substance is approved. Pallet boards are not approved.
